

# Data Privacy Satement WEINIG App Suite

### 1. Access rights

The WEINIG App Suite uses access to audio recordings, USB storage, network communication and the Internet.

### 2. Purpose

One component of the WEINIG App Suite is the ability to generate a service inquiry to receive rapid and targeted service support. Audio recording: The WEINIG App Suite offers the facility to create videos for a service inquiry. This requires access to audio recording.

USB storage: Videos and photos for service inquiries are stored on your device. This requires access to the device's memory.

Network communication and internet access: Service inquiries are sent via the Internet and machines and contact partners are updated via the Internet. This requires access to the Internet.

## 3. Storage and duration of storage

Duration of storage on the device: The photos and videos created by the app user for sending with service inquiries are stored on the device. The app user can decide when to delete this data using the delete function. The service inquiry history is stored and displayed on the device. Only the last 20 service inquiries are stored; older service inquiries are deleted. The app user can decide when to delete this data using the delete function.

Duration of storage by WEINIG: The service inquiries along with attached videos/photos are sent to WEINIG via the Internet and stored permanently by WEINIG. The resulting inquiry history for a machine allows WEINIG to support the app user by responding quickly and accurately to new inquiries.

The WEINIG App Suite gives the app user access to the WEINIG "Machine monitor" software systems, the WEINIG online shop and WEINIG news. No related data is stored in the App Suite.

## 4. Forwarding of information to third parties

Information submitted by the app user will not be forwarded to third parties.

## Confidentiality and data security

Weinig guarantees that all data submitted to Weinig via the WEINIG App Suite, as well as any product-related data, etc. will be used by Weinig exclusively for processing service inquiries. Weinig will instruct employees involved with the WEINIG App Suite accordingly.

Virus protection: App users and WEINIG will take appropriate cautions in accordance with the latest technology to prevent viruses from entering the IT systems of the other contractual party. Both parties particularly undertake to keep their virus protection up to date. In the event that viruses appear, or impair functions on systems of WEINIG or the app user or are capable of being transferred to systems of the other party, the other party must be notified immediately.

Responsibility: The app user is responsible for proper data protection and use in accordance with industrial constitution law of all data made available to the user via the WEINIG App Suite. The user shall instruct its employees not to forward access details they have received during registration to third parties.

Data protection, personal data: Where WEINIG requests personal data (e.g. name, address or e-mail addresses) this is, as far as is possible, voluntary. Personal data is only stored if you provide this voluntarily, e.g. as part of a registration, survey, review or when completing a contract.

### 1. Collection and processing of personal data

The website weinig.com only collects, stores or processes your personal data provided that this is permitted in accordance with legal regulations or that you have given your consent. Detailed information regarding all services offered via weinig.com and that process personal data can be found in this data privacy statement.

### 2. We obtain data in two ways

## 2.1 Data that you provide to us:

You can generally use our website without actively providing us with personal information. For some services, such as our press service, (see point 7.2) or the contact forms (see point 7.1), we will request personal information such as your name, e-mail address and company address in order to process the relevant service in an efficient and user-friendly manner or in order to be able to offer the service at all (we require contact details from the inquirer, for example, to process technician requests or an e-mail address to send press releases).

## 2.2 Data we obtain via your use of our services:

Some personal data is obtained automatically and, for technical reasons, once you visit our website. Whenever you access a page on our website or download a file (e.g. PDF data sheet), access data relating to the process is sent to our server. This comprises the following information:

- The page from which you have accessed our website
- The page from which the file/page was requested
- The name of the file
- The date and time of the request
- The data volume transmitted
- The access status (file transferred, file not found, etc.)
- Description of the type of web browser used
- The IP address you were assigned by your ISP, provided that this is necessary for the technical operation.

This information is not stored on our server. Personal data on user behavior is only evaluated on extent described in point 5.

## 3. Forwarding of data to HOLZ-HER

#### 4. Cookies

Cookies are small files containing a string of characters in which certain information is stored openly or encrypted. Cookies are sent to your computer from the server and stored on the computer. They are used initially to identify the computer from which a website is accessed. Each cookie has an expiry data after which it is no longer valid. Cookies allow a user's route through various pages of a website or even across various websites to be traced. Cookies can also be used to improve communication between our server and your computer in order to make your use of our website more convenient. Cookies may originate either from the website operator or integrated third parties (e.g. integrated social media networks or video platforms). You can use your browser to display the cookies stored on your computer, to delete the existing cookies or to change the configuration so that not all cookies or no cookies at all can be stored in future. This stores the acceptance of cookies.

This stores whether the reference to language navigation should be hidden.

#### Cookies from third-party providers:

## 5. Google Analytics

This website uses Google Analytics, a web analysis service of Google Inc. ("Google"). Google Analytics uses "cookies", small text files, which are stored on your computer and allow your use of the website to be analyzed. The information generated via the cookie regarding your use of the website is normally sent to a Google server in the USA where it is stored. If IP anonymization is activated on this website, however, your IP address will firstly be shortened by
